Service Restrictions: Unit Certification is not required for this product. If the manufacturer or purchaser request an ABS Certificate for compliance with a specification or standard, the specification or standard, including inspection standards and tolerances, must be clearly defined.

Comments: The flexible hoses are to be installed in accordance with the manufacturer's procedures and tested to the satisfaction of the attending surveyors. Carbon steel couplings, used for temperatures below 60 degrees Celsius, are to be normalized. The flexible hoses have been tested for fire resistance as per ISO 15540 and ISO 15541. The flexible hoses have been type burst tested to not less than four times its maximum allowable working pressure. Synthetic rubber hoses intended for use in bilge, ballast, compressed air, oil fuel, lubricating, hydraulic and thermal oil systems are to incorporate a single or double closely woven integral wire braid or other suitable material reinforcement. Synthetic rubber hoses intended for use in oil supply lines to burners, the hoses are to have external wire braid protection in addition to the integral reinforcement. To prevent danger of flooding due to failure of the hoses, the hoses in seawater systems are to be enclosed. In case of continuous operation at temperatures higher than 100 degrees Celsius, more frequent inspections and changes may be necessary. Hose clamps are not permitted except for cooling water systems for engines with a cylinder bore not exceeding 11.8inches (300mm).

Notes / Documentation: This Product Design Assessment (PDA) is valid only for products intended for use on ABS classed vessels, MODUs or facilities which are in existence or under contract for construction on the date of the ABS Rules used to evaluate the Product.

Term of Validity: This Product Design Assessment (PDA) Certificate 04-SG416938/2-PDA-DUP, dated 21/Apr/2016 remains valid until 08/Sep/2018 or until the Rules or specifications used in the assessment are revised (whichever occurs first).
